I. General

This is a firm, fixed price contract for the remodeling of an existing kitchen at U.S. Mission, Geneva, Switzerland to include, but not limited to the purchase, delivery and installation of new cabinets, work tables and appliances. The contractor shall complete all work, including furnishing all labor, material, equipment and services required under this contract for stated scope of work within the time specified herein. The total price for this contract shall include all labor, materials, overhead and profit.

II. Period of Performance

This contract is for a one-year period from the date of award, with one option year.

C . INSPECTION AND ACCEPTANCE (Move to Block 20 Scope of Work)

The Government representative shall inspect from time to time the contractor's work to determine a satisfactory work performance. The Government representative shall also perform a joint acceptance inspection of all equipment delivered to work site together with the contractor's representative prior to actual installation. If discrepancies are discovered during this inspection, contractor shall be responsible for corrective action in a timely manner but within no later than 3 working days from the date of discrepancies..

D - DELIVERIES OR PERFORMANCE (Move to Block 20 Scope of Work)

The Contractor shall commence the work within 30 calendar days from the date of the notice to proceed and complete the work not later than 30 days from the date of the notice to proceed. The required delivery date includes the time required for final cleanup of the premises and completion of punch list items.

II. PRICING

Pricing shall be in Swiss Francs and VAT exempt for the following categories:

- (a) Site work preparation, removal and disposal of existing furniture
- (b) Equipment (as detailed in Work Statement, Block 20. list and give price for every equipment required for this contract)
- (c) Kitchen modification (as detailed in Work Statement, Block 20)

(d) Delivery and installation

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

1. Project Title: US MISSION CONFERENCE KITCHEN REMODELING PROJECT
2. Place of Performance: U.S. Mission Geneva, 11 route de Pregny, 1292 Chambésy, Switzerland
First floor kitchen (non-CAA space).
3. Architectural/Engineering Support: Contractor/US Mission Facility Maintenance Section
4. Contracting Office's Representative: Facility Manager (COR)
5. Project Concept:
 - a. Purchase and install kitchen top and bottom cabinets using stainless steel material. Demo existing wood veneer cabinets.
 - b. A new walk-in refrigerator and walk-in freezer shall be installed.
 - c. The wall separating the kitchen and storage room shall be opened to allow a passageway between the two areas.
 - d. A small metal cage type wall in the storage room will be constructed.
 - e. A floor drain and drain channel shall be constructed at the kitchen floor to allow for wet cleaning of the kitchen.
 - f. Relocate ice machine in the storeroom and pipe in from nearest water source and install drain.
 - g. Purchase and install a new deep sink in the storeroom next to the ice machine.
 - h. Purchase a stainless steel preparation table in the storeroom.
 - i. Purchase and install new stainless steel top cabinets to be located directly above the new stainless steel preparation tables in the storeroom.
 - j. Purchase and install a new dishwasher similar to the dishwashing equipment at the 2nd floor Cafeteria.

- k. A new stainless steel preparation table shall be purchased and installed near elevator door.
- l. A second stainless steel countertop with built-in bottom refrigerator shall be purchased and installed in the storeroom.
- m. The existing pink tiles shall be demolished and replaced with white tiles.
- n. A new oven with stainless steel stands and steaming features similar to the existing 2nd floor Cafeteria oven shall be purchased and shall replace the old oven.
- o. All the existing stainless steel kitchen countertops shall remain but shall be cut and adjusted as necessary to fit in new dishwasher and other new equipment.
- p. Install a wooden platform just above the walk-in ref and freezer to be used for storage of light items.
- q. The new kitchen and storage room walls shall be repaired and repainted with a light neutral color similar to existing color.

6. Installation Details and Specifications:

- a. Purchase and install new kitchen top and bottom cabinets using stainless steel material to fit. Demo existing top and bottom wood veneer cabinets. Dimensions shall be 70 CM high x 40 CM deep. The top and bottom cabinets shall be divided into sections (approximately 80 – 90 CM wide) with stainless steel double doors and total length of all sections shall match the length of the existing stainless steel countertops. The new top and bottom cabinets shall have adjustable interior shelves. (See Drawing #1)
- b. A new walk-in refrigerator and walk-in freezer side by side shall be purchased and installed. Dimension of walk-in ref and walk-in freezer will each be approximately 1.5M deep and 2.2M height and 1.75M wide. (See Drawing #2)
- c. The wall separating the kitchen and storage room shall be opened to allow a passageway between the two areas and shall be 3M wide. The wall shall be demolished by the Contractor and the wall opening shall be repaired, finished, and repainted to the color of the rest of the walls. (See Drawing #2, and Photo #1)
- d. A small metal cage type wall in the storage room will be constructed approximately 2.6M wide as per attached design and shall be constructed up to the ceiling height. (See Drawing #2)
- e. A floor drain and drain channel shall be constructed at the kitchen floor to allow for wet cleaning of the kitchen. The floor drain shall be approximately 10 CM in diameter and drain channels approximately 12 CM wide and 5 CM deep and 3 M long shall be made so that no metal rebar on the floor slab is cut. The drain channels shall have a removable stainless steel grate cover for cleaning access. The floor drain shall be connected to the normal drain pipe below the kitchen floor. (See Drawing #2)
- f. Relocate ice machine in the storeroom and pipe in from nearest water source and install drain. (See Drawing #3, and Photo #2)
- g. Purchase and install a new deep sink (also install a faucet with extension hose type) in the storeroom next to the ice machine, and install drain pipes and new piping from nearest water source. (See Drawing #3)

- h. Purchase two stainless steel preparation tables for use in the storeroom each measuring 1.5M long by 0.7M wide, with an open bottom, and install them flush to the storeroom wall. (See Drawing #3)
- i. Purchase and install new stainless steel top cabinets for use in the storeroom, and to be installed directly above the new stainless steel preparation tables (See 9h). Total dimension shall be 3M long X 40 CM deep X 70 CM high and installed above the two new stainless steel preparation tables. The new cabinets shall be divided into sections (approximately 80 – 90 CM wide) with double doors and shall have adjustable interior shelving. (See Drawing #3)
- j. A new dishwasher shall be installed similar in style to the dishwashing equipment at the 2nd floor Cafeteria. Demo old dishwasher from under the countertop at the same location. (See Drawing #4, and Photo #4 and #5)
- k. An identical new stainless steel preparation table shall be purchased and installed near the elevator door 126 CM long x 65 CM wide x 90 CM high. The bottom of the new table shall be the same as the existing (i.e. half with drawers, and the other half for slide out trays). (See Drawing #4, and Photo #3)
- l. A second stainless steel countertop with built-in bottom refrigerator shall be purchased and installed in the storeroom. Refer to specifications on the existing refrigerator with stainless steel countertop and bottom refrigerator unit. (See Drawing #4, and Photo #7)
- m. The existing pink tiles shall be demolished and replaced with white tiles.
- n. A new oven with stainless steel stands and steaming features similar to the existing 2nd floor Cafeteria oven shall be purchased and shall be installed to replace the old oven. The existing stainless steel countertop shall be adjusted to fit in the new oven. (See Drawing #5, and Photo #6)
- o. All the existing stainless steel kitchen countertops shall remain but shall be cut and adjusted as necessary to fit in new dishwasher and other new equipment.
- p. Install a wooden platform 1.5M deep just above the walk-in ref and freezer to be used for storage of light items.
- q. Install new bottom running lights underneath all top stainless steel cabinets. Electrical conduit, wiring, and switches shall be installed by Contractor.
- r. The new kitchen and storage room walls shall be repaired and repainted with a light neutral color similar to existing color. Painting shall be performed at the end of the week or weekends to allow enough time for paint fumes to be cleared from the building.
- s. The Contractor shall coordinate with Conference Services and Facilities at all times.
- t. All Contractor workers shall be escorted by Facility Maintenance personnel, or kitchen staff depending on availability.
- u. All Contractor workers shall be cleared by the RSO Section prior to the start of the project.
- v. With limited support and assistance from US Mission personnel, the Contractor will mainly be responsible for moving office furniture, shelves, and other heavy obstructions in order to have room to perform their work. The Contractor shall replace the office furniture back to their original locations in a neat and orderly fashion.
- w. Other items currently stored in the kitchen storeroom but do not belong there shall be moved to other storage spaces or containers as appropriate.
- x. The Contractors shall be responsible in keeping the working areas clean and in the original condition of the spaces at the end of the workday.

- y. Disposal of all old kitchen equipment that is to be removed and/or replaced shall be performed by the Contractor or turned over to GSO.
- z. Two existing refrigerators and two freezers in the storage room shall be returned to GSO for proper disposal. (See Photo #8)
- aa. Workers will be provided with escorts at all times.

H. Deliverable Product:

The deliverable product for this project shall be a newly modernized kitchen with new cabinets and preparation tables; walk-in ref and freezer; passageway between kitchen and storage room; metal cage type wall in storeroom; new oven, new dishwasher; new deep sink, cabinet running lights, drains and drain channels as described in detail in Section 9 of this SOW – all installed in accordance with the manufacturer’s installation guidelines and industry standards. The Contractor shall perform tests to ensure all new equipment are fully functional according to manufacturer guidelines, and to ensure that all performance requirements have been attained and fully comply with this SOW as described in all Sections prior to final acceptance and sign off.

I. Government furnished materials:

J. Contractor furnished materials:

The Contractor will provide all new equipment and materials for this project and for construction, fastening, soldering, paint brushes, and similar materials which will be needed for proper electrical connections, control connections, painting, and other necessary work on the walk-in ref and freezer, deep sink, dishwasher, cabinets, etc.

K. Trash, Cleanup, and Disposal:

- a. The Contractor shall be responsible for the cleanup after work and disposal of all garbage items and demolition refuse using their own cleaning equipment and their own means to transport and dispose their garbage.
- b. The Contractor is responsible for moving kitchen appliances, office furniture, filing cabinets, and similar items to clear enough space for their work.
- c. The Contractor will replace these office furniture and other items back to their original locations each and every day until the completion of the installation.
- d. All offices spaces shall be left clean and presentable with all furniture back in place prior to end of Contractor’s work day.

L. Test and Acceptance:

- a. Tests on the new walk-in ref/freezer, new oven, new dishwasher, new refrigerator installation in accordance with manufacturer’s guidelines to test all functions of the new units.
- b. Acceptance for completion of all tasks under this delivery order shall be based on the successful completion of tests, quality inspection, and Government sign-off by the COR on all items successfully completed as described in detail on all sections of this document.

M. Quality Control and Warrantee:

- a. The Contractor shall perform quality work in accordance with accepted industry standards and keep the COR informed at all times on all pertinent issues on progress and quality.
- b. The COR reserves the right to inspect, propose, and rectify any quality issues on all work being performed.
- c. While a quality control inspection can identify many obvious and immediate problems due to poor quality, it may be possible that some hidden or less obvious problems will manifest themselves only after a certain period of time. Therefore, the Contractor shall provide for a warrantee of their finished work against piping leaks, malfunctions, and other problems that are deemed a result of poor quality work and related to the work that the Contractor performed for a period of six months from the date of acceptance.
- d. Any damages to U.S. property in the performance of this project by the Contractor shall be replaced, repaired, or paid at Contractor's expense or deducted from their fees.

N. Work Schedule:

- a. All work schedules including project start date shall be coordinated with Conference Services, Management, Facilities, and GSO.
- b. The Contractor shall comply with the work schedule as follows:
 - 1) Weekends:
 - a) Monday to Friday: start 8:00 AM to 5:00 PM
 - b) Saturday and Sunday (when needed or requested): 8:00 AM to 5 PM
 - 2) Holidays: Work to be allowed upon reasonable advance notice, availability of escorts, and approval of COR.
 - 3) Other working hours other than above can be requested with reasonable advance notice by the Contractor and shall be decided on a case by case basis by the COR.

(a) *General.* The contractor shall provide and maintain work environments and procedures which will safeguard the public and Government personnel, property, materials, supplies, and equipment exposed to contractor operations and activities; avoid interruptions of Government operations and delays in project completion dates; and, control costs in the performance of this contract. For these purposes, the contractor shall:

(1) Provide appropriate safety barricades, signs and signal lights;

(2) Comply with the standards issued by any local government authority having jurisdiction over occupational health and safety issues; and,

This notice, when delivered to the contractor or the contractor's representative on site, shall be deemed sufficient notice of the non-compliance and corrective action required. After receiving the notice, the contractor shall immediately take corrective action. If the contractor fails or refuses to promptly take corrective action, the contracting officer may issue an order suspending all or part of the work until satisfactory corrective action has been taken. The contractor shall not be entitled to any equitable adjustment of the contract price or extension of the performance schedule on any suspension of work order issued under this clause.

(1) Refusing, or requiring any U.S. person to refuse to do business with or in Israel, with any Israeli business concern, or with any national or resident of Israel, or with any other person, pursuant to an agreement of, or a request from or on behalf of a boycotting country;

(2) Refusing, or requiring any U.S. person to refuse to employ or otherwise discriminating against any person on the basis of race, religion, sex, or national origin of that person or of any owner, officer, director, or employee of such person;

(3) Furnishing information with respect to the race, religion, or national origin of any U.S. person or of any owner, officer, director, or employee of such U.S. person; (4) Furnishing information about whether any person has, has had, or proposes to have any business relationship (including a relationship by way of sale, purchase, legal or commercial representation, shipping or other transport, insurance, investment, or supply) with or in the State of Israel, with any business concern organized under the laws of the State of Israel, with any Israeli national or resident, or with any person which is known or believed to be restricted from having any business relationship with or in Israel;

(5) Furnishing information about whether any person is a member of, has made contributions to, or is otherwise associated with or involved in the activities of any charitable or fraternal organization which supports the State of Israel; and,

(6) Paying, honoring, confirming, or otherwise implementing a letter of credit which contains any condition or requirement against doing business with the State of Israel.

United States person means any United States resident or national (other than an individual resident outside the United States and employed by other than a United States person), any domestic concern (including any permanent domestic establishment of any foreign concern), and any foreign subsidiary or affiliate (including any permanent foreign establishment) of any domestic concern which is controlled in fact by such domestic concern, as provided under the Export Administration Act of 1979, as amended.

- (b) Certification. By submitting this offer, the offeror certifies that it is not:

- (1) Taking or knowingly agreeing to take any action, with respect to the boycott of Israel by Arab League countries, which Section 8(a) of the Export Administration Act of 1979, as amended (50 U.S.C. 2407(a)) prohibits a United States person from taking; or,
- (2) Discriminating in the award of subcontracts on the basis of religion
